Equipment will be the property of the player as long as the fee is paid in full

Billet Fee: \$500/month

ALL CLUB AND LEAGUE FEES ARE SUBJECT TO HST

2016 -17 Standard Player Agreement

THIS AGREEMENT MADE THIS ____ DAY OF _____, 2016

AMONG: The Elliot Lake Wildcats
(Hereinafter called the 'Club') OF THE FIRST PART

AND
(Hereinafter called the 'Player')

WHEREAS the Club is a registered Junior A Hockey Club playing in the Northern Ontario Junior Hockey League and operating out of the city/town of Elliot Lake in the Province of Ontario

Purpose

- The purpose of this agreement is to provide an outline and guide lines for all Players that play for the Elliot Lake Wildcats Hockey Club as to what is allowed and expected with the participation within the NOJHL and the Elliot Lake wildcats Hockey Club.
- This agreement will be enforceable by the Commissioner of the NOJHL and all sanctions and discipline rulings are not appealable to the NOHA, OHF or Hockey Canada.

This agreement is set out in the following section:

NOJHL Player's League, Showcase and Equipment Fee: \$2,550.00 + HST

Equipment deal:

1. Skaters Fee: \$1,064.00 + HST

a) Sticks, gloves, pants, helmet, visor and track suit

The equipment mention above will be the property of the player as long as the fee has been paid in full.

Player's Club Fee: \$2,450.00 + HST (This amount does not include the NOJHL Player's League Fee and the Equipment deal)

Player's Club Fees include:

1. 54 games (average 2-3 per week)
2. League showcase
3. Transportation to and from all games by highway coach
4. Road trip meals and hotel lodging
5. 4 Practises per week
6. 4 off-ice supervised workout per week
7. Private facility for game day stretching
8. Standard Academic Testing preparation for those players want to play University hockey in the USA
9. Full time paid coach to oversee the program

Club Refund Policy

1. As per the League refund policy
2. All Players who are traded and or released, or who suffer a season ending injury, are entitled to a refund of any participation fee based on the number of Club games remaining in the regular season schedule.
3. In the event the Player quits and/or leaves the Club anytime during the season, from the first regular season game and/or beyond, there will be no League and or Club Refund.

4. Any violation of the League and/or Club Policies could result in suspension, loss of playing privileges and/or dismissal from Club, with or without any Refund at the discretion of the NOJHL Commissioner.

Billet Fees: \$500.00 / month

- 1) All fees are paid to the billet family at the first of the month. Post dated cheques are recommended.
- 2) All players are to follow the team billet rules and those set in place by their individual billet family.

Community Service:

- 1) Players will attend all team functions and community services as required.

CLUB code of conduct:

- 1) Players will read and sign a separate team code of conduct.

Payment Plans:

Option A: Full payment of the NOJHL Player's League Fee and Player's Club Fee upon signing both agreements

Option B: Payment arrangements may be discussed on a case-by-case basis,

For each Player, the NOJHL Player's League Fee has to be paid in full before playing their first game (if the money is paid by payment the first payment has to be equal or greater than the NOJHL League Fee)

Player Discipline:

The parties confirm, acknowledge and agree that any violation of the terms of this Agreement will constitute a breach of the fundamental principles of the Northern Ontario Junior A Hockey League and/or the Club. A violation of any of the provisions of this Agreement, may result in the immediate suspension of the Player from participating in Club and/or Northern Ontario Junior A Hockey League activities, including, but not limited to, practices and/or games, for a period of not greater than twelve (12) months as determined by the NOJHL Commissioner and /or the Club Management or if constituted, the committee or individual(s) empowered by the Commissioner and the Club to oversee such matters. All decisions are final and may not be appealed to the NOHA, the OHF or Hockey Canada.

By signing this agreement, all parties fully understand the meaning of this agreement and have indicated so by signing it of their own free will.
